





AUGUST COMTE

- "Father of Sociology"
 - French philosopher who focused on improvement in society
 - Positivism: the use of scientific observation in the study of social behavior
 - He also distinguished between social statics and social dynamics
 - Social statics- study of stability and order
 - Social dynamics study of social change

HARRIET MARTINEAU






HARRIET MARTINEAU


- A writer, best known for analyzing Comte's work.
- She was a feminist who saw a link between slavery and the oppression of women
- She emphasized Sociology as a science
- She wrote often about the inferior position of women in society, and helped inspire feminist theorists.

Together with The Man versus The State







HERBERT SPENCER

- He focused his work on explaining social stability by <u>comparing parts of society to parts</u> of the human body.
- Functional Theorist
- All parts of society (like a body) are composed of parts working together for survival and well-being.
- Focused on Social Darwinism and evolutionary social change.

KARL MARX





KARL MARX

- Father of Communism –wrote *The Communist Manifesto*
- Focused on class conflict (the haves and the have-nots)
 - Bourgeoisie those that own the means of production
 - Proletariat the working class (paid just enough to stay alive)


K MARX (cont'd)


- A conflict theorist believed that capitalism would fail, because like slaves overthrew their owners, that the working class would eventually overtake capitalists.
 - FOCUSED ON EXPLAINING THE IMPORTANCE OF CONFLICT IN SOCIAL CHANGE.

EMILE DURKHEIM

- First sociologist to use statistical methods in research of human groups.
- He believed society exists because of a broad consensus – or agreement – among members of society.
- He thought human social behavior must be explained by social factors rather than psychological ones (ex. Suicide)

MAX WEBER



MAX WEBER

- He wrote about the nature of power, the nature of religions, and social classes.
- Human beings act on the basis of their own understanding of a situation. Therefore, sociologists must discover the personal meanings, values, beliefs and attitudes underlying human social behavior.
- Verstehen Putting yourself in someone else's shoes... (to best understand personal intentions in people in groups)
- Rationalization emphasizes the use of knowledge, reason and planning.

JANE ADDAMS


- More known as a social worker in the field of Sociology.
- Focused mostly on helping poor women and children – founded the Hull House in Chicago.
- She focused on the problems caused by the imbalance of power among social classes.
- She was active in the women's suffrage and peace movements.
- Won the Nobel Peace Prize in 1931-the only sociologist to do so...

W.E.B. DuBOIS





W.E.B. DuBOIS

- African American educator and social activists
- He focused on racial discrimination, after witnessing it first hand as a student at Fisk University in Nashville, TN. This led to him deciding to attach the 'negro problem'.
- He analyzed the social structure of black communities.
- Founded the NAACP in 1909.
- Did work in Africa, and died in Ghana at age 95

MARGARET MEAD



- Anthropologist studied people in cultures.
- Mead was a champion of broadened sexual mores within a context of traditional western religious life
- Her reports about the attitudes towards sex in South Pacific and Southeast Asian traditional cultures amply informed the 1960s sexual revolution.
